## RORY'S RECIPES: Sugar Cookies

*Our family loves to bake together, especially around the holidays! These sugar cookies power us through all of December, but we usually make so much dough that we keep making the cookies in the new year too because this dough freezes beautifully! I've been making this recipe for over 15 years now and my kids absolutely love it. Cookies don't have a season, so they are always appropriate!*

### INGREDIENTS:

- 1 ½ cups butter, softened
- 2 cups white sugar
- 4 eggs
- 1 teaspoon vanilla extract
- 5 cups all-purpose flour
- 2 teaspoons baking powder
- 1 teaspoon salt

### DIRECTIONS:


- 1 Cream together butter and sugar in a large bowl with an electric mixer until smooth. Beat in eggs and vanilla. Stir in flour, baking powder, and salt. Cover, and chill dough for at least 1 hour (but way better to refrigerate overnight.)
- 2 Preheat oven to 400 degrees and lightly dust a work surface with flour. Roll out dough to 1/4 to 1/2 inch thickness. Cut into shapes with any cookie cutter. Place cookies 1 inch apart on ungreased baking sheets.
- 3 Bake in the preheated oven until cookies are lightly browned, 6 to 8 minutes. Carefully transfer cookies to a wire rack and cool completely before decorating. 🍪




